STUDENT MANUAL

ADMISSION

IISc is open to all children, without distinction of class, caste or creed. The Admission Process comprises of certain norms.

- Admissions will be based strictly on merit. The decision to provide admission will be based in IISc's selection process. The decision of the Admissions Board will be final and binding in the case of all applicants. No queries or requests for reconsideration will be entertained in this matter.
- IISc is not equipped with facilities to test children with special needs. As such special needs. Are later observed / identified by IISc, then the decision of the management on such matters is final and binding.
- The application form will be available only on the days decided and as communicated by IISc.
- On acceptance of offer letter payment of the Requisite Fee should be made in full.
- Admission to IISc does not entitle automatic admission t any other / particular school.

ADMISSION RULE

The Admission Process comprises certain norms, which include:

- Completion of the Application Form in full with relevant documents as stated in the Application Form, including a copy of Aadhar card of the parents (government mandate).
- Prior interaction with the child and his / her parents or guardian to understand the child's background and aptitude.
- Physical verification of originals of all documents submitted with the Application form.
- Provisional or final Admissions will be granted subject to payment of fee and fulfilment of IISc Admission Procedure. The decision of IISc Admission Panel will be final and binding.

IISC ACADEMIC YEAR

The academic year commences on the 2nd of May of a year and closes on the 31st March of the following year. Every academic year is divided into two terms.

Term One : Commences from 2nd May and ends on 30th September of the academic year.

Term Two : commences from 1st October of that academic year and ends on 31st March of the academic year.



CODE OF CONDUCT

- 1. All correspondence with regards to the pupil should be addressed to appropriate authority and shall contain pupil's full name, class and section.
- 2. IISc facilities and programs are designed to cater specific requirement of student's as a group. Individual instruction may not be possible.
- 3. Parents are expected to attend, in the interest of their wards, all seminars and meetings organised by IISc.
- 4. IISc may organise programs for the orientation of parents on various issues related to the child. Meeting with IISc representatives may also be called for to discuss academic or other issues and attitude of the child. It is compulsory for parents to attend all the above programs and meetings in the interest of their wards.
- 5. In cases where IISc observes that an assessment or additional empowerment by an external agency is required for the pupil, whether academic, physical and psychological, the parents shall co-operate and provide the same.
- 6. IISc doesn't have either the expertise or the facilities for special education required for teaching pupils who are found to having natural difficulties in learning. In such cases, the parents are bound to follow the recommendations of IISc, including the recommendation to withdraw such pupil form IISc, if such phenomenon is not observed at the time of initial interaction.
- 7. If a pupil's behaviour and attitude are found to be disturbing, uncontrollable and harming the welfare of other pupils, the parents shall accept the recommendations of IISc, including the recommendation to withdraw such a pupil.
- 8. Parents and students are bound by the criteria and rules regarding promotion to next class.
- 9. No valuables like gold chains, bangles, watches, anklets etc. Are to be worn by any pupil. IISc does not take any responsibility for the loss of any such valuables.
- 10. IISc's decision on all the above and related issues shall be considered as final and binding on the pupils and their Parents / Guardians.
- 11. IISc requires full disclosure of the status of separation from spouse (in case) and clear declaration of the assigned Guardian for the child. A clear assurance that there will be no inconvenience due to current family status is also required.
- 12. IISc is entitled to amend all the rules mentioned above from time to time at its discretion, and the same shall be binding on the pupils and their parents.
- 13. For the purpose of any communication, if and whenever it happens, the email ID communicated to IISc shall be treated a s the official ID for the purpose.
- 14. Despite the child being under the teacher's observation, there are occasions when cases of fall/injuries have been reported. Such falls/ injuries occur due to the child attempting certain acts or during physical exercise or sports activities or anywhere within IISc premises for reasons beyond control. As such falls / injuries happen, despite precautions taken by IISc hence, IISc shall not be held responsible for such occurrences.
- 15. While IISc endeavours to give individual attention to all the children, it is not possible to give individual attention to a particular child constantly and continuously, although due care and all possible vigilance is always IISc's concern.
- 16. The management of IISc is not operating any school transport services and does not recommend any transport operator. We request parents to drop the children directly and pick them up from IISc. Incase of engaging the services of any private operator, the management recommends that parents shall conduct a proper verification / due diligence of transport operator before engaging the services of such private operators. The Management of IISc will not be responsible for any loss or conduct of such private operators.



GENERAL RULES

For the efficient functioning of IISc, the following requirements are binding.

- 1. Parents/Guardians are expected to cooperate with IISc staff enforcing regularity and Code of Conduct.
- 2. Punctuality and regular attendance are in the interest of the individual pupil, as well as the group with which the pupil interacts. The minimum attendance permitted is 75%. A student whose attendance falls below 75% may not be able to cope with the syllabus covered and hence, will not be ready for the next level. In such a situation, the decision of IISc will be final and binding on the parents. Specifically, prolonging vacations at either end is discouraged. A fine of 500/- will be levied if the pupil fails to attend IISc on the last day before vacations on the reopening day after a vacation.
- 3. Leave of absence has to be taken during the term for well founded reasons. This should be done with the prior written permission of the appropriate authority, who may consider the reasons given. It is the responsibility of the parents /Guardians to help the pupil learn the syllabus, which he/she may have missed.
- 4. If a pupil is unable to attend for medical reasons, the appropriate authority in IISc must be informed. If any infectious or contagious disease is indicated, the pupil must be certified free of such disease by Registered Medical Practitioner before returning to IISc.
- 5. Parents should avoid visiting IISc during class hours without prior permission of the appropriate authority, specifically direct entry to any class room or direct communication with any teacher during class hours is prohibited. In the event of an emergency, the appropriate authority should be contacted. Visiting hours for each class have been apportioned. Parents must seek a day's appointment to meet the Class Teacher during visiting hours.
- 6. Parents may not take any pupil out of IISc premises during term time without obtaining prior permission of the appropriate authority.
- 7. Although there is minimum practice work at home, parents are expected to ensure that such work is completed properly and submitted on time.
- 8. Parents/Guardians are liable for immediate reimbursement, on demand, of expenses incurred for repair or replacement of IISc property arising out of the actions of the child.
- 9. Wherever possible, things brought to IISc by the pupil should be properly marked for identification. These include books, bags, sweaters etc. IISc will not be responsible for the loss or damage to anything belonging to the pupil within the premises.
- 10. On birthdays, pupils are not permitted to distribute sweets, cakes, chocolates etc. The invitations for birthday parties should not be routed through IISc.
- 11. Parents are expected to ensure that pupils attend IISc in prescribed uniform (dress, sweater, shoes etc). Pupils are exempted from this requirement on their birthdays.
- 12. If a child, over a period of time, is found to be displaying aggressive behavior, causing physical or emotional trauma to the other children, the parents will be informed about such actions, in order to understand their view and also, the outcome of the expert's report, if already processed. IISc may, depending on the acuteness of the case, allow a reasonable time as per its discretion. If the issue sustains and no improvement is found, such child's tenure in IISc will be terminated for mutual benefits, as IISc does not have either the expertise or the facilities to handle such a child. Decisions taken by the Management will be final and binding.

ACADEMICS & AMENITIES

Modern research has provided the good quality infrastructure; scientific facility and techniques in school environment can greatly influence the overall well being and academic output of a child. Keeping that in mind Indian International School Offers a perfect mixture of good Infrastructure, quality ambience and modern amenities which act as catalyst in the child's learning process.
